Welcome to the first newsletter from the South Central Umpiring Transition Team - SCUTT for short!

As you are aware the way hockey is structured and managed will be changing from the beginning of Sept 2021, after the EH AGM resolution was passed late last year.

This resolution was branded as "A Structure Fit for the Future".

The structure includes how the country is split into different areas, how leagues will be restructured within those areas and how umpires will support the new areas and leagues.

The South Central Umpiring Transition team has been set up to oversee the transition from the current Regional and County based

umpiring and officiating structures to a new South Central Structure.

What this means is that there will no longer be the familiar Berks, Bucks, Oxon and Hants HUAs (Hockey Umpire Associations), but one central association that will look after the umpiring needs for the Area. This will cover developing, coaching, and supporting umpires, at all levels throughout the South Central Area, including appointing umpires to the leagues in the new area but excluding conference and national leagues.

As you can imagine there is a lot to cover and we as a team are keen to keep you updated as much as possible.

Over the coming months we will be sending out more comms to keep you up to date with all the changes, to let you know how you can get involved and what the plans are for the coming season.

# What does this change mean for you?

Whether you umpire just for your club, or are someone who takes appointments from their County, South region or NPUA, the way umpires across the South Central area are supported is changing.

However, this is not just about appointed umpires, it is about how we as an association/team can help and support everyone who picks up a whistle at all levels of the game from juniors to masters; new or seasoned umpires – we are here for you.

As your new Umpire Area team, we need to work out how best to organise and manage umpiring (including umpires and officials) across the South Central region to ensure as seamless a transition as possible from the existing HUA structures to the new Area structure, which will comprise the existing counties of Berkshire, Buckinghamshire, Hampshire, and Oxfordshire.

It is EH's intention that the new structure will be in place ready for the start of the 2021/22 season (Covid willing, of course) so we need to be ready to carry out all the functions that the existing HUAs carry out, and more.

This includes: Umpire development, Umpire Coaching, managing the area's finances, managing membership, liaising with higher level organisations, providing support to Club Umpire Developers, Discipline management, support to junior and masters competitions, and so on.

There is a lot of work to do, and we will endeavor to keep you up to date via your HUAs websites, emails and newsletters. If you feel you can help and support us in this transition, then please let us know. We are here to support you.
